


The territory has twenty-two countries, and speak four major languages with several dialects. The territory operates in eight different currencies. These countries are grouped according to the major languages as follows:















WAD IN THE 10/40 WINDOW BELT







WAD & GLOBAL ECONOMIC OUTLOOK

- According to the 2019 Wall Street report of the 25 Poorest Countries in the world, about half of those countries are from the West-Central Africa Division's territory.
- Also, in the 2019 Global Finance report of the poorest countries in the world, 17 of the states have less than US\$5,000.00 per capita of the Gross Domestic Product (GDP) based on the Purchasing-Power –Parity (PPP). Nigeria has less than \$6,000, and Cape Verde and Congo have less than \$7,000.
- Gabon and Equatorial Guinea have less than \$20,000 and \$40,000 per capita, respectively. Therefore, the three wealthiest countries in our territory are Congo, Gabon, and Equatorial Guinea. They have the largest per capita income, but the church has done the minimum amount of work in that territory. o

WAD & GLOBAL ECONOMIC OUTLOOK

- The twenty-two countries within the Division do not have stable economies, and their currencies continue to depreciate against the US Dollar.
- In 2016, for example, the exchange losses were more than the total appropriations received from the General Conference.
- In some countries, government workers have not been paid for months, and in most cases, the daily wage is less than \$2.00.

POLITICAL CRISIS AND THE EFFECT ON NATIONAL ECONOMIES

- Almost all countries in WAD have ongoing conflicts or have had some disagreements in the recent past.
- These conflicts have ravaged the economies to the level that they cannot survive without help or grants from other countries or the higher organization.
- These conflicts have brought about extreme poverty and diseases.
- In most of these countries, the citizenry cannot educate their children, and the level of illiteracy is very high. About 20% of the GDP is derived from Agriculture, whereas the developed countries have about only 3% generated from Agriculture.

POLITICAL CRISIS AND THE EFFECT ON NATIONAL ECONOMIES

These countries are not able to provide adequate budget for health and its associated challenges.

Diseases such as Malaria, HIV/AIDS, and the COVID-19 pandemic etc., are at precarious levels and have serious effects on the populations within our territory just as other Divisions.

>Healthcare is a major challenge indeed!

RELIGIOUS CHALLENGES

- Concerning religious activities, over 50% of the population in our Division are Moslems, and a high percentage are Animists, who are hard to reach.
- Despite these challenges, our Division is spending a lot of money and is making progress in soul winning.
- This effort is evident in the various evangelistic campaigns that have been held under WAD Impact and Pentecost 2018

RELIGIOUS CHALLENGES

The aforementioned challenges have affected negatively the finances of the West-Central Africa Division for the past ten (10) years.

. However, the Division has always developed new initiatives to mitigate losses and maximize gains to support the faithful church members to push the mission of the Church forward.

Strategic goal

Given the challenges above the Division was facing financially, a thorough study of the finances was made by analyzing and reviewing the past years' financial statements with a view of determining and attempting to close any loopholes and implementing plans that may inject revenue into the system.

EMPLOYEE PERSPECTIVE

EMPLOYEE PERSPECTIVE

- In the same vein, the worker must be satisfied to give his or her best to work.
- Workers' interests in our Division are food, shelter, and personal development.
- We determined to increase salaries and allowances to boost workers' morale, which we have achieved over the years. Today, we are not the last when it comes to employee remuneration.
- Our next plan is to find ways to empower our Church members so they may have enough money to give to the Church in tithes and offerings

EMPLOYEE PERSPECTIVE Cont'd

• We have developed strategies to enable workers to own places of abode upon retirement by introducing a pool of funds known as the Heritage Funds. The system has not helped workers only, but many denominational entities have been equipped to do business for the Lord. Efforts were made to provide a better healthcare system for our employees and their families.

FINANCIAL PERSPECTIVE

 \blacktriangleright In the process of reviewing the past years' financial performance, it was noted that tithe income was not enough to pay salaries and allowances, and the appropriations from the GC were the same or decreasing every year. Measures adopted aimed at reducing costs, promoting stewardship, and the possibility of increasing non-tithe incomes. Others included making fair use of our properties to increase revenue and invest in capital projects that would lead to consistent income flow.

INTERNAL PROCESSING

We make sure we respect policies and reduce costs in doing business for the Lord. We educate colleagues to adhere to accounting and administrative controls and minimize any existence of non-performing assets

GROWTH AND LEARNING

We develop new strategies and initiatives to generate growth. Besides, efforts were made to enhance church members' participation in the Total Member Involvement (TMI) program. We invest in human capital to enhance growth. The Slides below will show some of the successes resulting from the strategies we have discussed above.


SUCCESS STORIES

- The initiative to solve the employees' problem of accommodation after retirement has been a great success with introducing the Workers Fund (Heritage Fund).


- The Ghana Adventist Heritage Fund (GAHF) may be probably the strongest financially in relation to its counterparts in the other countries within the Division.
- The story is different today than it was about nine years ago when this initiative was introduced with a capital of \$100.00.
 - Today, it has a capital base of about US\$15,000,000.00. Many retirees have expressed appreciation to God for this initiative.

Financial Perspective

- Self-Support The self-support percentage rose from about 40% to approximately 115%
- The Self-Support rose to about 130% before the currency devaluation hit us in 2016.

REASONS FOR LOW LIQUIDITY RATIO

- Huge indebtedness to the Division by Unions and Institutions
- High volatilities of Currencies of countries of major Unions
- Liquidity ratio is above the policy requirement if Unions and Institutions settle their indebtedness
- Use of liquid funds for capital projects for strategic purposes
- Commitment to GC funded projects, eg. 13th Sabbath Projects

Tithe Income

Tithe income doubled from approximately 460,000,000 CFA in 2009 to approximately 950,000,000 in 2016

Tithe sharing income dropped to 630 million CFA in 2017 when the Unions voted decrease the tithe sharing percentage from 7% to 5%. The reason was to settle the indebtedness to the Division, but the debts went up further instead.

The world Divisions' average for the tithe sharing percentage is about 9%, WAD has never applied even 8% for tithe sharing.

Tithe Income

As of December 2019 the tithe sharing income is hovering around 940,000,000 CFA. This amount is less than the 2015 figure of 951,000,000 CFA.

In 2016, US\$1.00 = CFA 623.16, but in 2019, US\$1.00 = CFA 596.32. In terms of the US\$ therefore the 2015 tithe sharing income was the same as 2019 income of approximately US\$1,5 million.

NON-TITHE INCOME


- The non-tithe income increased from approximately 23,000,000 CFA in 2009 to approximately 770,000,000 CFA in 2015.
- Unfortunately, it decreased to approximately 630,000,000 CFA in 2016 and 450,000,000 CFA in 2017. The Non-Tithe Income as of December 2019 is approximately 659 Million CFA
- This was attributable to the devaluation of the Nigerian Naira and significant exchange rate volatility in the other major currencies within the Division.
- This significantly affected the projected investment income and also the Guest House income due to the use of the place for church programs and the effect of COVID-19.

Financial Perspective EXCHANGE LOSS



Bassam Land – A 4.86 hectares of land was purchased at 24,000 CFA per sq. meter near the Abidjan airport for the future headquarters of the Division since the current office compound is small and has security challenges in times of political crisis. Money was borrowed from the retirement fund for this investment. Currently, the price per sq. meter has increased to more than double of what we paid for.





• Dakar Land – This land was acquired for future development. It is a 40-acre land near to the new international airport of Senegal.

- To ensure efficiency and effectiveness in its operations, the facility has been leased to a company experienced in the industry.





CHALLENGES



There are several financial challenges faced by the Division. There is low employment in the region. Some workers have not received salaries from the government for several months. There exist a high percentage of Muslims (about 50%) living within the Division's jurisdiction. Besides, animists comprise a more significant percentage, and cultural practices and beliefs are predominant.





The Division has fourteen out of the twenty-two countries as Frenchspeaking countries, as listed above.The income from these French-speaking countries forms less than 15% of the total revenue.The Portuguese and Spanish speaking countries income are part of the French-speaking countries. Only two countries, Ghana and Nigeria, contribute over 80% of the total Division revenue. These two English countries supporting the Division have currencies weak and volatile, unlike the French Speaking Countries..

One significant difficulty the Division has been contending with is the inability to transfer funds from Nigeria due to financial regulations freely. Where transfers have been done, in both Ghana and Nigeria, the cost of such transfers have been very high. Ironically, these are the countries with the highest accounts receivable. As the funds stay in these two countries, and with the constant devaluation and exchange fluctuations of the currencies, the Division loses both funds paid on their behalf and the tithe funds to be forwarded to the Division.





- Adventist University of Cosendai
 - •During this same period, the Division was able to save the Adventist University of Cosendai and all the Church institutions, including the Union office Buildings which had been pledged as collateral, when the University took a loan of 1,000,000,000 CFA from a Bank in Cameroon for campus development that did not go well. The Division had to pay off the loan to safeguard the institution and the other Cameroon entities from total collapse.

 We have put all measures to address the challenges in the 2020-2025 Strategic Plans.
 We believe by following the plans; we can indeed reduce the obstacles if not entirely removed.
